

PRIZING: One (1) prize winner will receive one (1) prize package (the “All Star Weekend Trip”) consisting of: (i) two (2) round trip coach-class airline tickets from an airport close to the winner’s home to Toronto, Ontario, CA; (ii) one (1) standard hotel room for two (2) nights at a hotel in Toronto, Ontario, CA, to be selected by DGG; and (iii) two (2) tickets to the All-Star game and All-Star skills competition (held on February 2-4, 2024).

To the fullest extent permitted by applicable law, winner’s guest (the “*Guest*”) may be required to sign a liability/publicity release to be eligible to travel with winner to Toronto, Ontario, CA. Both the prize winner and Guest must have a valid passport that does not expire within six (6) months of the travel dates. Winner and permitted Guest of winner are responsible for obtaining all travel arrangements at their own expense to and from all activities and events that are components of the prize (unless otherwise explicitly set forth herein) and hereby acknowledge that DGG has not and will not obtain or provide travel insurance or any other form of insurance for any travel associated with the prize.
